Digital Images are accepted on CD or as attachments to e-mail in JPEG format only, maximum six 2MB images. Clearly label CD with artist name, title, media, size (H x W x D) to correlate with entry form & JPEG image.

Work that differs from the original image submitted will not be accepted. The judge reserves the right to deny exhibiting works not of the quality projected in the photo submissions. No changes in the title, sale price or value may be made after the selection process. Accurate, legible information must be provided with the application.

Images of work submitted will not be returned and if accepted by judge may be used for PR purposes and/or on the ADSO website. Selected pieces must be available for the entire show. All artwork must have a declared value for insurance purposes.

Eligibility

Open to artists 18 years of age and older, living in the United States. All forms of art are eligible including painting, drawing, sculpture, photography, graphics, and ceramics except art installations, work previously shown in the space, or entries that have won an award in a previous ADSO exhibition. Work must have been completed after Jan 1, 2010. Submissions must be original and entirely the work of the artist, without supervision of an art instructor. Pieces should not exceed 65 inches in any direction, including the frame.

Liability

All work is insured while at the Mattie Kelly Arts Center Galleries. ADSO and the NW Florida State College, their officers, employees, directors, members, volunteers or anyone connected with the exhibition will not be liable for damages during shipping. We suggest artists carry their own insurance for this purpose. Damaged shipping containers will be returned unopened. Signature on entry form indicates agreement with these conditions.

Awards

Prize money will total \$2,000. As a *special award* for the first-place winner of \$1000, a one-person show will be arranged in the Holzhauser Gallery of Mattie Kelly Arts Center Galleries during the 2013 Southeast Regional Juried Fine Arts Exhibition. The balance of prize money will be awarded to the 2nd and 3rd place winners.

Standards

Accepted entries must be ready for gallery installation. Framed, two-dimensional pieces must be properly matted with a heavy wire attached securely to the back. Plexi-glass is recommended for shipping. 3-D pieces must be able to be handled comfortably by two people. Any piece requiring assembly must be assembled by the artist at a time arranged with NWFSC.

Works may be picked up at the Mattie Kelly Arts Center Galleries on Saturday, June 9, from 10 am – noon.

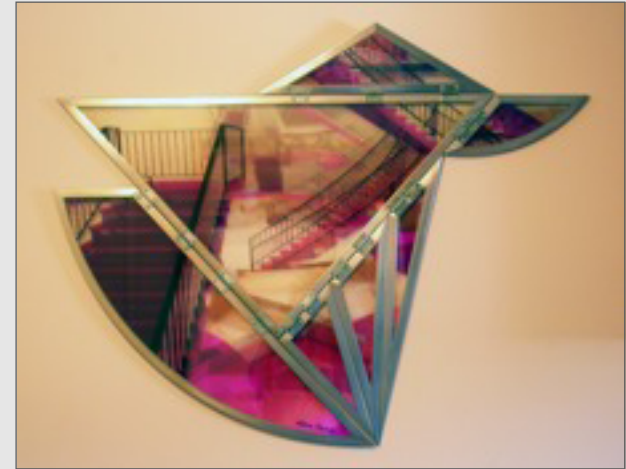
